Clinical Integration

The Infirmary Physician Alliance (IPA) is a physician-led, physician-driven, and physician-governed organization that is aligned with Infirmary Health to provide physicians with a more integrated role in strategic planning, patient care and quality program implementation, and managed care contracting with payers/employers. The Infirmary Physician Alliance's main goal is to improve clinical quality and the care efficiency necessary to demonstrate value to payers/employers and patients.

BPCI Advanced with CMS Under Review by the IPA Board

The CMS Bundled Payment for Care Improvement Advanced (BPCI) program is a bundled payment for all clinical care costs during a 90 day episode of care. There are currently 33 inpatient episodes and 4 outpatient episodes that are a part of the new program set to begin in 2020. BPCI Advanced qualifies as an “advanced payment model” under CMS. The application deadline was June 24, 2019 and the IPA submitted a non binding letter of intent to review the data. During August-October, the IPA will receive all CMS claims related to each bundle in order to conduct a preliminary bundle opportunity analysis. This analysis will be reviewed by the IPA committees and Board to decide whether to apply for a three year bundle. Participation in the program requires a final application by November 1st. If the IPA decided to apply, participation will begin January 2020. Below are the BPCI Advanced Bundle options that can be selected by the IPA.

Outpatient Percutaneous Coronary Intervention (PCI)	Disorders of the liver excluding malignancy, cirrhosis, alcoholic hepatitis
Outpatient Cardiac Defibrillator	Double joint replacement of the lower extremity
Outpatient Back & Neck except Spinal Fusion	Fractures of the femur and hip or pelvis
Outpatient Total Knee Replacement	Gastrointestinal hemorrhage
Bariatric Surgery	Gastrointestinal obstruction
Inflammatory Bowel Disease	Hip & femur procedures except major joint
Seizures	Lower extremity/humerus procedure except hip, foot, femur
Transcatheter Aortic Valve Replacement (TAVR)	Major bowel procedure
